The flagship international conference of the IEEE Industrial Electronics Society (IES) dedicated to the dissemination of new ideas and investigation in the field of, among others: power electronics, renewable energy, generation, transmission and distribution of electricity, power systems and EMC/EMI issues.

Date: The conference will be held on June 24-26, 2024 in Gdynia.

Scope: The aim of the conference is to ensure high-quality interaction between industry and scientists for the development of science, technology and society. The conference will include invited keynote speakers and regular and special sessions.

Organizator: The conference is co-organized by the Maritime University in Gdynia.

Participants: Conference participants will include scientists and industry representatives from around the world. Apart from Polish participants, we expect guests mainly from the European Union countries, as well as from China, the USA and the Middle East countries.

Deposit currencies:

The expected conference fees paid by participants will be made in 3 currencies: Polish (PLN), American (USD) and euro (EUR).

Online payment regulations

§ 1 Definitions

For the purposes of these regulations, the following terms have the following meanings:

1. Client– a person who makes payments to the Service Provider under contracts binding it with the Service Provider.
2. Service Provider – Gdynia Maritime University; Morska 81-87; 81-225 Gdynia; NIP 586-001-28-73, REGON 000145112.
3. Online payments are handled by the PAYNOW payment operator, provided by mBank S.A. based in Warsaw at ul. Senatorska 18, entered into the Register of Entrepreneurs kept by the District Court for the capital city of Warsaw, 12th Commercial Division of the National Court Register, KRS register number 0000025237, NIP: 526-021-50-88, REGON: 001254524 (hereinafter referred to as PAYNOW) The rules and online payment terms are specified by PAYNOW at <https://www.paynow.pl>.

§ 2 Preliminary provisions

1. The Service Provider provides services to Client based on the contracts concluded with them.
2. Services provided by the Service Provider are paid.
3. The Service Provider enables Clients to pay for the service using electronic payment, which is done as follows:
 - a) The service provider generates a payment link
 - b) The Client will be redirected to the online payment operator's website,
 - c) The Client will be able to use the payment methods described in § 3 above.

§ 3 Payment operator

1. Electronic payments, including payment card payments, are handled by the mElements S.A. operator based in Warsaw at ul. Prosta 18, Entered into the Register of entrepreneurs of the National Court Register by the District Court for the Capital City of Warsaw. Warsaw, 12th Commercial Division of the National Court Register under KRS number 0000590484, with the tax identification number NIP: 522-304-78-92
2. The administration of the personal data is mBank so the payment is made based on mBank's regulations, which the Client accepts by submitting a payment instruction.

§ 4 Payment methods

1. Online card payment:

a) payments can be made using Visa, Visa Electron, MasterCard, MasterCard Electronic, Maestro.

b) transactions of selected operators are additionally secured by the 3DSecure standard, using the Verified by Visa and MasterCard SecureCode payment authorization protocol.

2. Credit card payment online (VISA, MasterCard, Mastepass).

3. Link automatic payment:

a) is a service offered by banks consisting in automatic completion of a transfer form and simple authorization of the transaction carried out by the Client,

b) the payment is guaranteed, so each message sent by mBank ensures that the Client's bank account will be debited.

b) the transfer is made on the basis of the generated data that the Client completes independently in electronic banking

§ 5 Payment refunds

1. If it is necessary to return the payment made by the Client, the refund will be made to the bank account assigned to the payment card that was used by the Client in the original transaction, unless the Client has agreed on a different solution with the Service Provider.

2. In any case, the Client will not incur any fees in connection with the form of refund.

§ 6 Payment Complaints

1. The Client may submit a complaint if the payment services laid down in these regulations were provided contrary to the conditions and principles specified in the mBank regulations or the Payment Services Act.

2. The Client should submit a complaint regarding the services directly to mBank. The complaint should be submitted by the Client immediately.

§ 7 Final Provisions

1. The Service Provider reserves the right to make changes to the Regulations. The Regulations in force on the date of conclusion of the contract shall apply to contracts concluded before the amendment of the Regulations.

2. These Regulations are valid from December 1, 2023.
